

## Baserri Shotguns

### Three-Year Limited Warranty

A new Baserri Shotguns firearm is warranted to the original retail purchaser, for 3 years from the date of purchase. This warranty applies only if the firearm was purchased from an authorized Baserri Shotguns dealer in the United States or Canada, or off of the Baserri Shotguns website at [www.baserrishotguns.com](http://www.baserrishotguns.com).

Baserri Shotguns will repair or replace, at its option, without charge any Baserri Shotguns firearm that fails due to a defect in materials or workmanship. Parts and labor are included. Repairs are warranted for the duration of the original warranty. If Baserri Shotguns replaces a firearm under this warranty, you will receive a new 3-year warranty from the date of the replacement. Baserri Shotguns will return replacement firearms to you freight prepaid.

Briefly describe the problem(s). We will determine if your firearm is eligible for warranty repair. If so, you will be issued a Return Authorization Number. Guns are not accepted for repair without a Return Authorization Number. If a warranty registration is not on file for your firearm, you must provide Baserri Shotguns satisfactory proof of date of original purchase. Only a sales receipt or a properly completed warranty registration card for a new Baserri Shotguns firearm will establish eligibility for warranty repairs when a product is returned.

Pack your firearm for shipment to the Baserri Shotguns repair facility (address listed below) in the following manner:

- Ensure that the firearm is completely unloaded, by visually and physically checking the chambers and the magazine. It is both dangerous and illegal to ship a loaded firearm through the mail, and you should call Baserri Shotguns for assistance if the gun cannot be completely unloaded for any reason prior to shipping.
- DO NOT PACK OR SHIP LOADED FIREARMS. SEND NO AMMUNITION.
- Place your firearm in the original box with the spacers in place to prevent damage in shipment. If you do not have the original box then ship the gun, unassembled, in the case Baserri Shotguns provided at purchase.
- Please include a letter containing the Return Authorization Number you've been given, and a description of the problem. Be sure to include your name, address, and daytime phone number. Insure the package for the replacement value of the gun, and ship the package, freight prepaid, to Baserri Shotguns Industries at the address listed below. No C.O.D. shipments will be accepted. Only the Baserri Shotguns repair service facility is authorized to make warranty repairs.
